# Establishments and Companies Services

- Site survey (for 1 day).
- Geological survey of the site 3 months / 6 months
- Mining excavation of the site 3 months / 6 months
- Axial drilling.
- Processing of mining ores (for 1 year).
- Sand, gravel and building stones trading.
- Permit to exploit the site of a crusher /quarry (for 1 year).
- Cement manufacturing.
- Manufacture of rock wool.
- Glass manufacturing
- Ceramic manufacturing.
- Lime manufacturing
- Manufacture of concrete and cement products
- Dyes and paints manufacturing.
- Adhesives manufacturing.
- Sandpaper and grinding materials manufacturing.
- Permit plant of sand wash /sorting and filtering sand.
- Plant of ready mixconcrete.
- Plant of asphalt production mixers.
- Manufacture of ready mixconcrete buildings.
- Plant for the production of decorative tiles & brick.
- Plant for the production of brick (sand, cement, limestone- clay).
- Plant for recycling mining waste.
- Removal a mountain and site reclamation (for 1 year).
- Laboratory for the examination and analysis of rocks and minerals.
- Opening tunnels and mountain roads.



- Registration the customer information.
- Registration the company information.
- Permit to exploit areas to store materials with an area of 100 square meters (today / month / year).
- Rehabilitation of environment that surrounding the working establishments to maintain the security and safety of citizens
- Export permit for mining products to mining establishments (New/Renew).
- Export mining products for one time that specified for 1 year in the trade license.
- To Whom It May Concern certificate for establishments (two months).
- Permit to explosives companies (New/Renew).
- To Whom It May Concern certificate.
- To Whom It May Concern certificate to perform excavation and explosion works.
- Explosive Permit.
- Permit to acquire explosives.
- Issuance card of the representative of a mining establishment.
- Temporary experimental operational permission for three months/ sixmonths.
- Adding a new production line for mining establishment.
- Permit to write, draw, engrave, or place pictures or posters on mountains and rocks.
- Issuance the weight reports for products of mining establishments.
- Permit to service companies that licensed outside Fujairah and contracted with mining establishments in Fujairah (day - month – year).



## Individual services

- Permit of crusher products.
- Permit to transport Daffan materials for UAE citizens.
- Permit to transport sand materials (red sand) for UAE citizens.

## Transport services

- Issuance identification cards for trucks on weighbridge that subsidiary to service centers.
- Permit to transport Daffan materials for companies.
- Permit to transport sand materials (red sand) for companies.
- Permit to transport Daffan materials with passage on weighbridge - Dibba Fujairah Branch.
- Permit to transport Daffan materials to breaker anchorage.
- Pass cards to workers of all companies related to manage and operate breaker anchorage.
- Temporary pass card to visitor to enter barge anchorage in breaker (day / month).
- Truck driver's pass card with equipment.
